The 2024 Mother's Day Classic

The Mother's Day Classic (MDC) is now 27 years strong and is proudly celebrated as Australia's largest annual fun run and walk for breast and ovarian cancer research. It's a tradition that brings tens of thousands of Australians together each Mother's Day, connecting communities with a purpose.

Since 1998, the MDC has grown from a small walk in the park to a national movement with up to 75 events across Australia. Over the years, 1.7 million participants have united and inspired the community to donate over \$47 million for lifesaving cancer research.


While breast cancer survival rates have improved, with five-year survival rising from 84% to 92% since the MDC began, more progress is urgently needed. Breast cancer remains the most common cancer among women.

Tragically, the five-year survival rate for a woman diagnosed with ovarian cancer remains at 49%, with no non-invasive early detection test available. Every day in Australia, nine women die from breast cancer, and with ovarian cancer, that number rises to 12. One death is too many.

Since 1998 each Mother's Day we've been dedicated to walking, running and fundraising to save women's lives. In 2024, we took one step further and made it

our mission to stop both ovarian and breast cancer in their tracks. In the last 27 years, our community has donated \$46.1 million to the National Breast Cancer Foundation, and since 2024, \$1.2 million to the Ovarian Cancer Research Foundation.

Together, we're moving towards the goal of achieving a future where all women diagnosed with either breast or ovarian cancer will be given the assurance they can survive.

2024 was a groundbreaking year for the Mother's Day Classic (MDC). For the first time in our 27-year history, the MDC community expanded its mission to encompass support for both ovarian and breast cancer research.

These contributions underscore the MDC community's strength and unity, as well as the unwavering dedication of our fundraising champions and supporters, including our newly inducted Classic Champions, Cristina Campagna and Trevor Lockwood, who achieved outstanding results as our top fundraisers of 2024.

I would also like to express heartfelt gratitude to our MDC Foundation Board for their strategic guidance and commitment. A special farewell goes to Rob Pickering, whose invaluable leadership, particularly in IT and digital strategy, has strengthened MDC for the future. Rob is now embarking on an exciting new role in London, and we wish him continued success.


Our 2024 event saw 120 Local Hosts deliver 64 local events, each bringing a unique energy and passion to their community. I'd like to recognise the recipients




